Agenda 1: Update - 2014 Lexington, Kentucky - Tom Phillips

Tom has been working on securing a professional auction company for the Lexington Show in 2014. He has received no responses; however, with some persuasion, Glass Works Auctions has submitted a proposal. It was explained by Tom and is basically the same as this year with the exception of the Federations commission, which would now be 6% instead of the Manchester National 10%.

Action taken:

On recommendation by Tom Phillips, a motion was made by Sheldon Baugh to approve the proposal made by Glass Works Auctions to handle the 2014 auction at Lexington, Kentucky; Bob Ferraro seconded motion. All members were in favor.

Tom said this information should be posted within the September | October issue of Bottles and Extras.

The contracts for the 2014 National Antique Bottle Show in Lexington will be available by the Manchester show date.

Agenda 2: Update - FOHBC Bylaws - Gene Bradberry

The final revisions have been made to the bylaws and members were sent copies via e-mail earlier tonight. Gene explained that due to the change in dissemination of Federation information (such as putting information on the FOHBC website), necessary revisions needed to be made to the bylaws to reflect these changes.

Gene began by noting that two additional revisions were suggested for:

(a) Article IV Governing Body (page 7) Director-at-Large #2 - delete 'past presidents and vice presidents' and rewrite to read, 'any previous elected officer.'

(b) Article IV Governing Body (page 5) Treasurer #1 - to be revised to delete 'shall have custody of all dues, funds, and securities of the Federation' and replaced as 'with the exception of other board directed funds.'

The other proposed revisions include:

Article IV Governing Body - Secretary #1

Article IV Governing Body - Treasurer #5 (change to 'and/or')

Article V Committees and Contracted Activities - L (change to 'regional'), O

Article VII Meetings and Conduct - B #7 (addition), C #7 (addition) [Briefly discussed this addition with suggestions] Gene will re-work this item and forward to members again for review.

E #5 (will be revised to eliminate the 'two months')

Article IX Amendments - A, B #1 (adding and/or instead of just or on A and B), C #3

Action taken:

Gene Bradberry will make the corrections and forward to all board members for final review. The information on the revision of the bylaws, will be published on-line with an insert in the magazine (*Bottles and Extras*) to check on-line for an explanation of the changes being recommended. The general membership should be able to review before the final ratification at the Manchester National Board Meeting in July.
